- V. Executive Director's Report: (Johnstone)

Several Ordinances, including BYOB Regulation, will be proposed at a public hearing, taking place at Borough Hall tonight at 6pm. The Busking Ordinance hearing will be scheduled to a later date. Pennsylvania Downtown Center (PDC) recognized West Chester as a "Nationally Accredited Program" by the National Main Street Center. West Chester is one of only three communities in PA's Southeast Region to be accredited. The West Chester BID has been invited to apply to be a Façade Improvement Pilot Program that is being created by the National Main Street Center for State Programs. The Board of the Chester County Historical Society has appointed Elizabeth M. Laurent to the position of President, effective July 25, 2016. Jasmine Smith will join CCHS as Librarian, effective July 25, 2016. Frank Herron has approved \$3,000 in Bartenders' Ball funding to support the Budweiser Clydesdales Parade on September 2, 2016. Remaining funds will be distributed, in varying amounts, to the Chester County Hero Fund, West Chester Fire Dept., West Chester Food Cupboard, and the West Chester BID. Denise Polk has made a written request to the BID for funding to support WCU's compost pilot program. The motion (Gusz / Walsh) for \$600 in BID support of the program was withdrawn, and further discussion tabled until Advocacy meets with Denise, and a recommendation is made to Board.

#### Street performers

Borough Council is considering implementing regulations that will permit street performing, also known as busking, to occur in the Borough. A hearing was held on Tuesday, August 2, 2016, and was continued to Wednesday, September 21, 6pm.

#### Tom Wang hired for the clean-up program

Downtown will have a regular schedule of clean-up operations now that Tom Wang has been hired by the BID to perform duties of downtown sidewalk cleaning and managing community service working in those efforts as well. He will be providing about 70 hours a month.

#### Parking director hired

Clark Elms, who had been most recently the Impark manager at the Chestnut Street Garage, has been hired as the new Borough Parking Director. He began August 1, 2016.

#### Council approves creation of Community Initiatives Page on its website

Borough Council recently approved the creation of a "Community Initiatives" page on the Borough's website. The purpose of the Community Initiatives webpage is to promote postings, exhibits and displays of interest, information, and enlightenment for the citizens of West Chester to view for community focused organizations and institutions. Entities and groups eligible to submit messages for posting on the Borough's website and social media feeds include:

The fuzzy-footed giants will clippity-clop along Gay and Market Streets between 6pm to 8pm. Specifically, it starts at Gay and Matlack Streets, then proceeds west to Darlington, south to Market, and east to Walnut Street. Working with the restaurant community that have transferred funds to the BID, the BID is helping to make this event possible by ensuring that the cost of police assistance is paid for in a timely fashion.

# West Chester Business Improvement District Advocacy Meeting July 22, 2016 | 8am Minutes

The previous meeting minutes were reviewed with no objections.

#### Pfizer property

Jim indicated that a group of investors was working to acquire the Pfizer property to develop a year-round facility for sports and recreational activities.

#### Downtown cleanup/Big Belly

Meghan advised the group that the Borough has started a bi-annual program of washing the Big Belly trash cans. New informational decals will be placed on the Big Belly cans. There was also discussion about how the BID can assist Public Works with leaf collection. It is expected that Tom Wang will start August 1, 2016, to perform clean-up operations.

#### West Chester Together

The WCU coordinators of West Chester Together are planning to promote West Chester Together during the student orientation and Swingin' Summer Thursday in September, and will have a couple of booths during the September event. It's part of a drive to get students into West Chester and forming relationships with West Chester right away. At the student orientation and at the booth, they are planning on having give-away's - some geared toward students (e.g., t-shirt, pizza cutter), and another geared toward Borough residents, most likely a reusable shopping bag with West Chester Together on it, and information about WCT. WCU has allocated funds toward these and other efforts, and I am writing to ask if the BID would be able to co-sponsor the printing of the bags, and perhaps include BID/West Chester information in the bags as part of the give-away. The overall cost for printing 500-700 bags is about \$1000 - \$1500. Again, WCU has some funds for this, and of course would be delighted if the BID would consider co-sponsoring it. The Committee recommends approval of a \$250 sponsorship.

#### **Compost Pilot Program**

Denise Polk, administrator of the program, sent the following to the BID:

I'm contacting you to update you about our pilot. We have had numerous delays, the biggest one being an issue with the EPA changing one of their systems, and we couldn't access our funds.

The two most recent delays have been:

- 1 two participants backed out, and we haven't been able to find willing replacements
- 2 there was a \$1600 increase in a equipment cost for the Borough truck

The Borough has agreed to pick up that \$1600 cost. The EPA is willing to let us run our program with 8, not 10 participants; however, that's \$1200 of money we won't be getting from the restaurants as part of their participation fee. The EPA will let us proceed if we can cover \$600 of those \$1200 lost costs. Is this something that the BID might be willing and able to invest in? I ask because we have 8 signed contracts, and I really don't want to keep delaying the launch of the pilot any longer. They're eager to get started. The signed participants are:

I realize this is something you hadn't budgeted for. As a reminder, each participant is paying \$600 for the year (breaking down to \$50/month). This helps defray the total hauling and equipment costs, meaning that every invested party (EPA, restaurants, Borough) is contributing some money to the project. I hope the BID might be able to help us out, given these most recent circumstances.

Thanks for your consideration. If you'd like me to provide more details of the budget breakdown, I will be happy to do so.

#### Comp Plan

Holly advised the group that the West Chester Comprehensive Plan is scheduled to be completed by December, 2016.

#### Parking garage signage

Clark Elms is the new Borough Parking Director. He will be invited to discuss the situation with the signage on the outside of the Chestnut Street parking garage. They are failing and should be replaced.

#### **Downtown Banners**

While Borough Council has approved the concept of installing new banners downtown, funding is not forthcoming. However, Malcolm advised the group he will meet with the new director of CCHS, Elizabeth Laurent, and will discuss banner options with her.

#### **Bus Shelter**

There was discussion about the need for a bus shelter at High & Gay. It is likely that there are no public funds to support this but there may be an opportunity for private funds to build one. Timothy Phelps from TMACC will be invited to meet with the group and further discuss this.
