Borough Council approves BID Preliminary Plan to Final Plan

(per e-mail by Holly) After a three hour meeting on September 22, the Borough Council voted 4-3 to accept the Preliminary Five Year Plan as the Final Plan. There were two minor adjustments: 1) a street correction for parcel 0108 04350000 and 2) a note indicating that the 2016 budget is a "proposed" budget. This was done at the insistence of Councilman Abbot, who stated that BID should not assume that they would be receiving the \$85,000 contribution from the Borough.

The positive votes came from Ms. Koopman, Mr. Braceland, and Mr. Norley. The no votes were from Mr. Scott, Mr. Shin, and Mr. Abbott. With Ms. Jones absent, the Mayor cast the tie breaker which gave us a 4-3 victory.

As a result of the vote, the 45-day period for stakeholders to cast a no vote began and will end on Friday, November 6. If fewer than 40-percent of the stakeholders file objections by that date, the Council will then advertise and hold a hearing to enact an ordinance adopting the Final Plan. This will occur at a Council hearing on Tuesday, November 17, 6pm.

Several downtown property owners, retailers, and stakeholders attended the meeting to speak on behalf of the BID. Thank you to Lara Ross, Len Doyle, Stephenie Stevens, Dave Fairman, Kathleen Vaughn, and David Reinfeld for sitting through more than two hours of questions and comments in order to show their support.

A huge thank you to Suzanne Adams and Stephen Pitcherella for taking on the task of preparing the plan, and to Elizabeth McGuire for, as always, her unending helping hand.

BID Re-Authorization: The West Chester BID Five Year Plan (2016-2020) was adopted by Borough Council at a Special Public Hearing on September 22, 2015.

Clydesdale Event: A great event! Bigger and more organized than last year's. Malcolm worked closely with downtown liquor license holders to ensure that they are RAMP certified.

BLUER: (Mozacco) Charter ends first of the year. An ordinance from Council is needed to develop a *Sustainability Advisory Committee*/SAC. Mozacco would remain involved in an outside advisory capacity.

Clean & Green: (Gusz) The committee approved a quote from Gary Zang with an annual cost of \$400 to enhance the two flower beds on the northeast corner of Gay / High. Malcolm is to approach QVC to secure additional funding. A communication from BID to property and business owners is necessary as a reminder to clean their sidewalks and to advise that the Borough will be enforcing fines.

Mapping program

Malcolm demonstrated the Google My Map system which allows multiple platforms for virtually any application. The mapping system was introduced by Internet RND, a downtown business, and is available at no cost to the BID which will manage the program in-house.

Manager's Report

Malcolm reviewed the packet of materials with the committee which is customized for each prospect. It generally includes such items as the Downtown Guide which automatically includes every restaurant and retailer, the Destination Downtown West Chester booklet as an overview if the BID as a resource agency, the Brandywine Traveler as a curated attraction piece, and the Then & Now of Historic West Chester supplement demonstrating the historic character and preservation culture of downtown. Also included are pages of available properties with contact information.

Other items

Regarding the vacant space at 127 W Gay, it was suggested that Malcolm contact the Chester County Historical Society to have them consider a window display at that location and work with the property owner to try to make it happen.
